EXHIBITOR INFORMATION

- The event opens to the public at 10:00 AM and closes at 3:00 PM.
- All exhibitors with a fixed location are asked to be in place no later than 9:30 AM. Autos to be exhibited are asked to arrive no later than 9:00 AM.
- There will be a check-in station for exhibitors from 8:00 AM until 9:30 AM, where exhibitors may pick up their exhibitor badges, lunch vouchers, and a map showing exhibit locations.
- Fixed location exhibitors may park their vehicles at the end of White Rock Road on the portion of road that parallels the freeway, but the vehicles parked there may not leave until after the event is over at 3:00 PM. If you will need your vehicle during the day, park in the public parking lot at the entrance.
- No motor vehicles will be allowed to drive on White Rock Road in the event area between 10:00 AM and 3:00 PM, except (1) the big antique auto parade and tour at 10:30, (2) the small antique auto parades throughout the day, (3) any emergency vehicles, and (4) the event golf carts.
- Directions to the event: From Sacramento drive east to El Dorado Hills and exit at Silva Valley Parkway. At the top of the off ramp turn right onto Silva Valley Parkway and then immediately turn left onto Old White Rock Road. GPS: 1598 White Rock Road, El Dorado Hills, CA 95762
